During a divorce, a valid retirement benefits court order may be issued at any stage of a divorce, annulment, or legal separation proceeding, in order to divide your TSP account, according to the Federal Retirement Thrift Investment Board. This may award your current spouse, former spouse, or dependents, a specified dollar amount.

TSP requires a separate order to permit them to send Jane the amount awarded to her in the decree. Jane can elect to have the money moved in a taxed or non-taxed way directly with TSP. The TSP order does not have to wait for the employee to retire for the former spouse to send it to TSP and receive payment.
